



CLIMATE FINANCE IS AN OBLIGATION OF THE GLOBAL NORTH TO PAY FOR THEIR HISTORICAL AND PRESENT RESPONSIBILITY FOR CLIMATE CRISES.



RURAL FAMILIES IN BANGLADESH ALONE SPEND AT LEAST **\$2 BILLION A YEAR** (\$79 A YEAR PER HOUSEHOLD) TO ADDRESS CLIMATE CRISES ²





CLIMATE FINANCE MOSTLY END UP IN THE HANDS OF FINANCIAL INSTITUTIONS AND PRIVATE INTERMEDIARIES TO FUND FALSE SOLUTIONS INCLUDING MEGA PROJECTS BY CORPORATIONS FROM THE GLOBAL NORTH





RICH COUNTRIES CONTINUE TO FAIL THEIR POLITICAL COMMITMENT OF \$100 BILLION PER YEAR TO TACKLE CLIMATE CRISES, EVEN WHILE KEEPING THE 1.5C GOAL ALIVE REQUIRES AT LEAST \$4.5-5 TRILLION ANNUALLY ONLY BETWEEN 2021-2030 '



CLIMATE FINANCE USUALLY COMES IN THE FORM OF LOANS. THIS FURTHER PUSHES POOR COUNTRIES INTO DEBT BONDAGE AS THEY ARE ALREADY SUFFERING FROM HISTORIC LEYELS OF DEBT.
